


Quarterly Report *January - March 2025*

The Grand Junction Police Department Animal Control Unit was established in January 2025, following a restructuring of Mesa County Animal Services operations. While Mesa County Animal Services provides shelter services, the Grand Junction Police Department addresses animal control issues within the City of Grand Junction.

The GJPD learned of the restructure in mid-summer of 2024 and worked diligently to prepare an Animal Control Unit from the ground up, ensuring it was fully operational by January 1, 2025.

With a strong focus on excellent customer service and reuniting lost pets with their owners, the new Animal Control Unit has already made a meaningful impact. In just three months, this team of dedicated Animal Control Specialists handled **1,164** animal-related calls for service and successfully reunited **85** animals with their owners.

Since launching the GJPD Animal Control Unit, we've had the opportunity to collaborate with amazing community partners who share our dedication to animal welfare. We're grateful for the support and look forward to continuing these efforts together.
